ONLINE DUAL CREDIT PARENT/STUDENT AGREEMENT

Student Eligibility

- Highly motivated and self-disciplined SCS students in grades 11 and 12 are eligible.
- Students must have a cumulative weighted GPA of at least 3.5 and be capable of earning at least a B in an Honors or AP course in a similar subject.
- Earning a grade below a B- in a Dual Credit course will make you ineligible for additional dual credit courses.
- SCS may monitor your progress in this course, but you are solely responsible for the completion of all coursework by the assigned due dates.
- Parents should monitor their child's progress and should not expect notification from SCS regarding academic progress in this course.
- A significant homework load (approximately 1-2 hours daily) will be necessary to fulfill course requirements.
- Students must provide their own laptops, tablets, and other electronic devices.

Registration and Fees

- Important: Completion of this form does **not** register you for the course.
- Once this form has been approved by SCS, you are responsible to register and pay for the course through the university.
- Proof of registration must be submitted to SCS as soon as you have completed the registration process.
- Registration for the course should be completed as soon as possible, but no later than 3 weeks before the beginning of the course to ensure acceptance.
- If for any reason you do not complete this course, you may not enroll in an SCS course after two weeks have passed in the SCS semester. Note: failing to complete the course may result in being required to earn credits through alternate means at the student's expense.
- It is strongly recommended that you be fully committed to successful completion of this course before enrolling.

Class Attendance/Course Credit

- Daily attendance at SCS is required during the assigned class period while you are enrolled in this course. You will be assigned a room for completing coursework.
- Only one study hall is allowed at SCS per semester. During the semester in which you are *not* enrolled in this course, you must enroll in another dual credit course, an online course, or a course at SCS. If you have no other study halls, you may enroll in a study hall.
- You will receive credit for one semester at SCS per dual credit course completed. The number of college credit hours is determined by the university.
- College credits and transcripts are available only through the universities. For college credit transfer information, contact the university.
